- III. SWP Report Funds Overview
 - a. SWP Local July-January

 - v. MC get extension for R7; R8 remaining; R9 untouched

 - i. MC needs to move from R6 to R7, which is still not enough; overflow covered by R8

- V. Workgroup to create process for redistributing funds
 - a. Yes, interested
- VI. Centralizing community outreach and workforce development
 - a. Short on manpower; a need for this in the district
- VII. Collaborative bachelor's degree
 - a. Meeting with Mike at CVC state chancellor's office was invested
 - b. If there was an opportunity to offer more than 1 bachelor's program in CTE areas, offer 4
 - c. If there is interest, may want to request LMI data now for the submission in the summer; will take 3 months to do the element (takes a long time to pull all the resources)
 - i. Mary saw increased enrollment when increasing from 2 to 4 year
- VIII. Chair Updates: CE Master Plan, Apprenticeships, CPL
 - a. CPL
 - i. Executive summary for the Career Education Master Plan for California: 100M going towards CPL
 - 1. 33M will be allocated directly to colleges and districts to support the expansion of CPL need to fulfill 3 criteria
 - ii. PCCD method of Credit exam may violate title 4 (enrolling students in close course sections and then charging tuition)
 - iii. Need to figure out a funding mechanism

- 1. Pay CTE faculty out of Perkins; investigate Lake Tahoe; how to translate the hands on courses? Must develop the rubric
- 2. How does it affect veterans
- b. Automatically awarded certificates report to come
 - i. Need auto awarding to be functional
 - ii. Would help with spending SWP funds
- IX. District wide collaboration: surviving efficiencies
 - a. Information changes day to day
 - b. Fee-based programs
 - c. Challenge to dual enrollment: finding instructors willing to go to outside facilities (schedules so different)
 - i. Check to see if there is a CTE program at all are there any HS teachers with a CTE credential that would meet MQ of what PCCD offers
 - Bring students in virtually (wouldn't help with the prison systems as it would require internet) – state prisons all have internet, but none in the district
