Atiya Rashada - Presents last year's ASLC Scholarships flyer & how well the categories did. Last year's ASLC got creative & made new categories. Reward of \$250 for each scholarship. Homeless - Got difficult, hard to find out if a person was actually homeless. Athletics - Received none.

Atiya Rashada - Recently received \$43K, which means different stuff goes in different categories.

FV - Goes to facilities or events?

Atiya Rashada - Scholarship money will go out of events. Questions can be brought up on Signal.

Maya - Applied for senator yesterday.

Atiya Rashada - Emailed some folks that asked a series of questions.

FV - Small interview for this semester will happen at the next meeting.

AR - Needs official candidates. Encouraging everyone to campaign for 4 weeks. CT is creating a campaign packet, if they don't want to create a flyer, they can fill out a packet instead. Student protest form to challenge election results - out of compliance.

JG - Can a teacher vote/promote me?

Atiya Rashada - ASLC can't vote for a single individual, if so, must do for everyone. On ASLC website if anyone wants to know. Questions?

JG - Do we need to apply for every single position to campaign or is it only needed to campaign for 1 position?

AR - One position.

JG - Does a senator need to?

AR - We need a selected number of voters to vote.
