- a. Resolution Urging Consideration and Understanding of CE Courses in any FTEF Allocations
 - i. Rooted in the state plan for CTE
 - ii. What is the goal/objective of the resolution? Try to lay out the importance of CE to the District wants a fair share
 - 1. Document is very long
 - 2. Should be clear to deans and VPI's what the "ask" is
 - 3. Perhaps could break it down a little more provide highlight or the most salient points
 - a. Wanted to point out several policies, but open to edits
 - 4. FTEF allocation criteria should include livable wages
 - iii. Have it ready for new Chancellor to see
 - iv. What suggestions are there to make it less wordy?
 - v. 20% fund 01 and 80% fund 11 (resolution is backwards) do this for completely new course or under a completely new context
 - 1. A class can be funded by SWP if it's never been funded by general fund
 - 2. Where is this policy written? Nowhere, but Las Positas and SFCC does it this way and is confirmed also by Diana Bajrami
 - 3. Does this have to be in the resolution? Yes
