All our classes were full this fall. Why is this happening? I know there is more money in the cash reserves. A consistent recommendation has been to cut down the expense of a way too large district administration. We are trying to serve the people of Oakland and the east bay. West Ed showed us.

Lowell Bennett- Thanks Chris for highlighting that issue. Apologize for some of the comments that I made at the PBC where I focused on targets. Focus on assessing the need for the future. 16-week Calendar	The proposal comes from VPIs at colleges. SDroker	

The VPI and I meet regarding a 16-week calendar. What are your thoughts? Allows us to have a more robust intersession. Start of a conversation.

Dr. Bajrami- we are looking at data and patterns. Accelerated courses are doing very well. The challenge is we can only offer 3-week courses. Create multiple entries for students to a more robust intersession. DVC has been successful. Kuni- I come from a district that comes from a compressed calendar. Will allow the colleges more ftes. The cycle of our life is so great to have about a month between terms. Finish classes earlier. Do a lot of prep, retreats, planning. Our district only claims 52.5 instead of 54 that we are allowed to do. We need to bring clear data to increase our revenue, and help our students offer different entry points.

DBajrami- student success and retention were much better in 33 different colleges. 17.5 weeks we are losing students. Great quality of learning.

Matthew Goldstein- what are the mechanics of that?

Dbajrami-gain 2 weeks into the full semesters.

MGoldstein- different length more opportunities, more intersession.

Khay- changing 17.5 to 16. Contact hours range expands as it shrinks.

NJones- term limit multiplier calculation. Formula. MGoldstein- not more bodies but calculating in a different way. If our goal here is to generate more revenue, how that money would be used in advance? This is a wonderful opportunity to do more planning where we have failed in the past.

Dbajrami- that will be done first before we move forward. More time for longer intercessions, 4-unit courses.

Challenges that we have encountered are complex. Time sensitivity. Need to provide our instructional leadership so they can begin developing their schedule for next year. Time crunch. We decided to propose short term and long-term budgeting processes look like. Incorporate different elements to the process for making a determination as to what is appropriate target or resource allocation to support that. Need to increase sections. We don't have a lot of flexibility in the course of the year. SDroker- we have improved we are far below, 2000 below. 85% OF TARGET this fall. Specific for dual enrollment. Long term approach was based on the faculty work group. Look at best practices for a more robust allocation model.

Dbajrami- make an intentional, support growth, offer more courses post covid. How we are going to divvy up, 3-year average. First option- let's use the dual enrollment ftef.

Project. Favor the colleges that have seen some growth.

Dr. droker we will email this out to everybody so we can focus on the questions.

Khay- 40 ftef. Is it possible for the workgroup to share how we should be calculating the costs? Our plan is in alignment with the budget. Guide us to consistently figure the cost factors.

NJones-look at your budget. The position control and what is the salary for your time faculty. Line item for part-time faculty. Overall employee benefits, look at how those are broken out.

Allocating funding that is under the partial tax. Look at those things in tandem. Historic cost of the part-time faculty. Up to the individual colleges working with their business officers and their vpi's.

MFreeman- these 2 options will be shared with the chancellor at cabinet on Monday.

NJones- focus group specifically for faculty. Resources provided
