Updates

Student Priorities & Updates

Sergio M- Not much to update, most students were pretty stressed out with transferring. Tragedy at BCC, shelter in place incident that happened at Cal. Connection between those students, breakdown in communication. Some people received an email but I did not.

Didem Ekici- The district has an app for this very purpose. It is not being used. Strongly suggest that you email student services that not all students notified, only some. It might be a technical issue.

College DE Committee updates

BCC- Cora Leighton- I signed up for Nixle. Should be easy to send messages to tech update. Kuni Hay was saying that we should be able to send a push notification to students. We didn't have a lot of updates because of multiple traumas on campus, all meetings were canceled. Funding for POCR reviews. I have been asked by Bob Nash to join a panel at the online teaching conference around Hyflex in Long Beach.

Chris Bernard- Trying to figure out what the plan is for next year for POCR, provided opportunities over the summer. Collaborating with professional dev to try to figure out a pathway. The training and work that it requires. Different from reviewing courses. We are doing some stuff collaboratively, don't have the infrastructure. Some projects that we have done. We are on the fringes as we work toward becoming Pokr certified.

COA- Jennifer Fowler- Last week we had our DE meeting. Release time for DE coordinators. Our college is getting less release time than the other colleges. We talked a lot about funding. The enormous work it takes to get a class aligned. Faculty feel overworked with the accessibility. We brainstormed some low level ideas. I plan to reach out to our PFT reps, negotiation in the future. Partner with PFT to come up with ideas.

Nora Mitchell- POCR coordinators meet monthly. Appreciate the help and guidance. I hope that will continue.

Laney- Melissa McElvane- Our Laney DE team reviewed the modality list from ACCJC. Some feedback to share. Pokr mentorship program showcased on Friday. 6 mentors, 7 mentee. Our DE coordinator interviews began on May 3. A number of candidates. Interviewing process. Judy

reapplied along with other candidates.

Merritt- Adoria Williams- We talked about the ACCJC changes in DE. Discussed Respondus and POCR. We are moving forward with the plans to revise what we were told as far as the courses that we submitted. Mandatory meeting next month.

District DE Coordinator update

Didem Ekici- DE coordinator load update. Up to .4 to all coordinators at each college. Above .4 up to VPIs. Laney and Merritt got 1.0 and BCC and COA got .4. We had two separate meetings with VPI's. This is the final decision. We are trying to find solutions to close this gap. We don't want any services to be affected by this allocation. Unfortunate, happened because of communication.

VoiceThread- We have to pay \$38,000 to renew. In the past it was Covid related funds. All this funding is gone. Trying to use our money efficiently. If Canvas Studio can replace VoiceThread. Since it is free maybe we can save. The limited user means 1,200. Currently there are 900 using it. Provide Canvas Studio related training.

Respondus- 56 users so far. We are planning to collect data from students to make a better decisions. Quick survey to faculty and students, what kind of support they need from the district.

Cora Leighton- Kuni told us 9% of students responded to the survey last semester. Is not a represented sample of our students. Administration keeps saying we don't know what the students want. Not data that we can actually use. How we can work to implement the survey that gets effective data? Folks can sign up for Nixle updates in their area (Berkeley etc.). Didem Ekici- Sending it first to faculty then through emails. We can encourage faculty. Nothing about faculty, only evaluating the tool. Suggestions about the wording that the faculty may be offended. Suggestions on how to reach out to students.
