BACKGROUND/ANALYSIS:

Through our internal evaluation, an additional recommendation was made for Peralta to retain the consulting firm Huron to complete an assessment and review of the business processes that will be implemented during phase 2 of the PeopleSoft upgrade. This was completed to ensure Peralta is following common business practices for Community Colleges of California as well as best practices.

Huron's recommendation and validation of our work established that following our success in the first phase of the PeopleSoft upgrade, we should enter into an additional contract with Oracle to implement all recommendations listed in the report from Huron. (For more details, please refer to the attached Huron Report)

Completing the modernization process with the additional recommendations from Huron, represents an opportunity to improve PCCD's business practices and improve the user experience for students, faculty, and staff. The new modules with enhanced recommendations will enable improved cross-functional workflows and will allow PCCD to enhance operational efficiency.

- Position Management

- Time and Labor
- Commitment Accounting
- Asset Management
