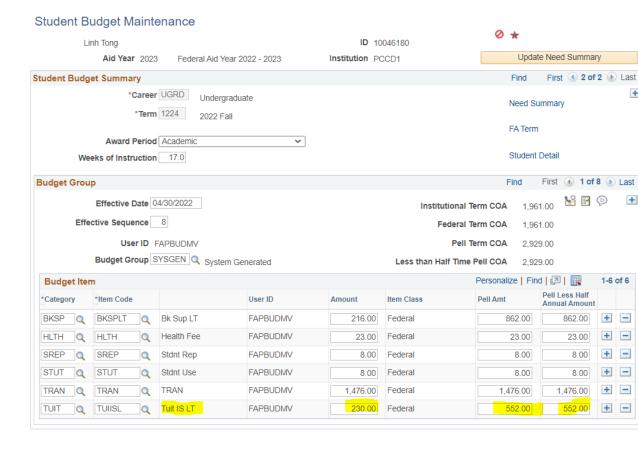

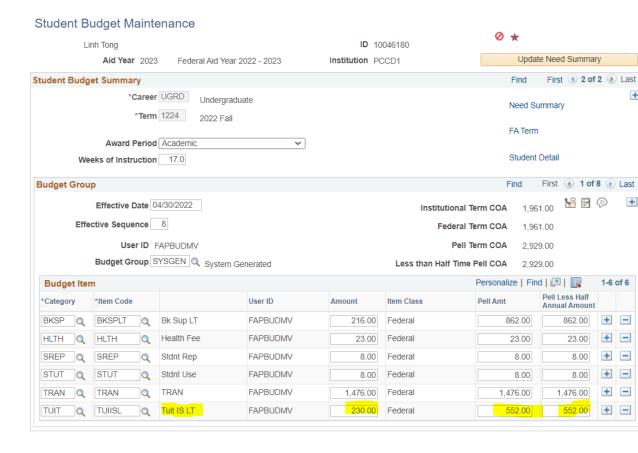

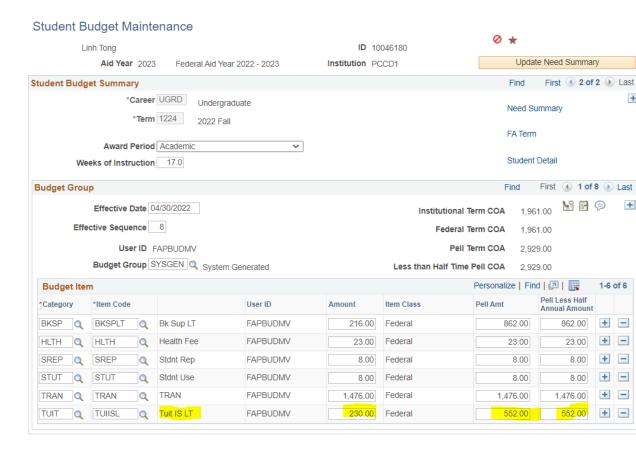

Problem

Laney and our sister colleges have received a significant increase in errors / rejects between what was awarded in PeopleSoft and rejected in C.O.D. That means that we have given money to students that is rejected by COD and thus we cannot drawdown those funds via G5 until the error is corrected.

Problem

Normally, we receive a query from the district with the errors/rejects and the colleges Program Specialists review and make the corrections for the students' files to be accepted by C.O.D. and then we can drawdown the funds. The issue is we have received queries with no reason codes. Our staff cannot make a correction if they don't know why the students file was rejected by C.O.D. Currently, Laney nor our sister colleges can reconcile given this dilemma. We have no resolution to our problem as of yet

Challenge

Unfortunately, as I advance concerns, they are being dismissed as non-systems errors when they clearly are, and no solution is being provided by the district so the colleges can reconcile. I am not interested in blaming anyone, I need our colleagues to collaborate to identify the challenges more effectively I listed above so we can have a solution and reconcile.

The colleges (not just Laney) all noticed increased errors after the upgrade, so there is a correlation. The questions I posed are not directly answered and thus we cannot achieve a solution. Regardless of whether files were externally tested or not; 1) I need the district to clearly support us in identifying what has caused the increased errors and 2) when will they provide us queries with reason codes for the errors? Please remember, we cannot correct an error from the C.O.D. without knowing the reason.

I'm not sure why but I would appreciate it if you could look into this Donna Hooper- 10614167: Her SAP status shows as "MEET," but she's Max Hours. Under the Maintain Student SAP Data page, the maximum attempted units show as -866.50.
