SPECIFICATIONS OF THE ELECTION ORDER

WHEREAS, Education Code 5322 requires that any school district or community college district election for governing board members shall be called by the governing board of the school district or community college district;

WHEREAS, the specification order must include: date of the election; purpose of the election; authority for ordering the election; authority for the specifications of the election order, and signature of the duly-authorized officer;

NOW THEREFORE, BE IT RESOLVED that the Board of Trustees of the Peralta Community College District does hereby determine the following:

- The election date for the election of Governing Board members to the Peralta Community College District Board of Trustees shall be in November, even years; hence November 8, 2022;
- The purpose of the election is to elect or re-elect Governing Board members to the Peralta Community College District Board of Trustees, to fill the seats vacated by the end of terms;
- Authority for the specifications of the election order is outlined in Education Code section 5322.

NOW THEREFORE, BE IT FURTHER RESOLVED that the Board of Trustees of the Peralta Community College District does hereby determine the following:

- The candidate is personally responsible for the cost of printing, handling and mailing a candidate's statement of qualifications;
- The candidate shall personally submit additional materials to the Registrar of Voters;
- The candidate shall personally submit the statement of qualifications to the Registrar of Voters;
- That the Registrar of Voters be directed to give a copy of these regulations to each candidate or his/her representative at the same time s/he obtains his/her nomination papers;
- That these policies shall remain in full force and effect until rescinded by this Board.
