### CANDIDATE'S STATEMENT OF QUALIFICATIONS

**WHEREAS**, Section 13307 of the Elections Code of the State of California requires this Governing Board to adopt certain policies in regard to statements of qualifications for candidates who run for office for the Governing Board of the District;

**NOW THEREFORE, BE IT FURTHER RESOLVED** that this Governing Board of the Peralta Community College District does hereby determine the following:

- The candidate is personally responsible and will be charged for the cost of printing, handling and mailing of a candidate's statement of qualifications in English only (except where otherwise require by law);
- The candidate shall personally submit the statement of qualifications, not to exceed 200 words, to the Registrar of Voters;
- That the Registrar of Voters be directed to give a copy of these regulations to each candidate or his/her representative at the same time s/he obtains his/her nomination papers;
- That candidates shall not be permitted to submit additional materials to be sent to the voter with the sample ballot;
- That these policies shall remain in full force and effect until rescinded by this Governing Board.
