# 2023 Health Benefit Changes **Peralta Community College District Employees**

New Medical Anthem Plan 2 (Formerly PPO Lite) Effective March 1, 2023

Response for the New SISC Anthem Plan 2, due by January 27, 2023

#### **CORRECTION**

- 1. This special open enrollment is being extended through 1/27/23.
- 2. The district corrected the error regarding former PPO Lite employees and any price change to their coverage.

## All Employee:

Following up, within 90 days of the Board of Trustees' approval of the SISC Plans, the District has worked with SISC to provide an additional PPO plan option. This plan will offer a lower employee cost share and the same provider network as the new SISC Anthem PPO Plan. The new plan (SISC Anthem PPO 2 - Formerly known as PPO Lite) will be added effective March 1, 2023.

This is a special Medical Open Enrollment opportunity to switch to the new SISC Anthem PPO 2 Plan effective March 1, 2023. The new SISC Anthem PPO 2 Plan will be offered to members at the same PPO Lite employee monthly contributions rates listed below:

Single \$15/monthly Two-party \$30/monthly Family \$45/monthly

#### What do I need to know?

- 1. If you are currently enrolled in a SISC Anthem medical plan and want to move to this new SISC Anthem PPO 2 Plan, you must complete a new enrollment form. You will have the opportunity to add and drop eligible dependents.
- 2. If you are currently enrolled in a SISC Kaiser medical plan and want to move to this new SISC Anthem PPO 2 Plan, you must complete a new enrollment form. You will have the opportunity to add and drop eligible dependents.
- 3. If you are currently waiving medical coverage and want to move to this new SISC Anthem PPO 2 Plan, you must complete a new enrollment form. You will have the opportunity to add and drop eligible dependents.

- 4. If adding an eligible dependent, you must provide the required documentation; please refer to the Eligibility Checklist.
- 5. This is **only** a special **Medical** Open Enrollment opportunity to switch to the new SISC Anthem PPO 2 Plan, effective March 1, 2023.

REVISED Note to former PPO Lite Employees: If you were enrolled in the Anthem PPO Lite Plan before January 1, 2023 and continued to the SISC PPO Plan, and take no action, your monthly contribution will continue to be grandfathered at the same rates unless you take other action. No specific action is required at this time unless you wish to change to the SISC Anthem PPO 2 plan. The rates remains as follows:

Single \$15/monthly Two-party \$30/monthly Family \$45/monthly
