  - i. Classified Professional: Tabled until next month's meeting
- IV. Goal Setting Draft Discussion
  - a. Indirect costs: New Vice Chancellor of Finance needs a new discussion; a draft already in process since spring
    - i. Needs to know about what funds are available
  - b. Lab Technicians: everyone starts at the same level is off-putting. Makes attracting new hires and retention hard
  - c. SWP regional funds formerly used by CE liaisons' CCAOE conferences (fell to the wayside) is a discussion possible to do this again?
    - i. Helpful to know the costs
    - ii. Discuss with Constance to determine what's available
  - d. Can software billing be moved back to annual (versus fiscal year)? Changing of software in the middle of summer is disruptive.
    - i. Used to use 0897 (IELM funds), but those funds are no longer available so it will be paid by the colleges going forward
    - ii. Dr. V's team working on starting payment process for new FY items earlier.
      - New processes on contracts and direct pay that hopefully can help everyone going forward
