1. Call to Order and Introductions

The meeting was called to order at 3:11 p.m. without quorum by Chair Schoffner and introductions made.

5. <u>Year to Date Parcel Tax Report Review – Budget Expenditures</u>

The Finance Department provided two (2) reports on the Parcel Tax.

Presentation on Measure B FY 2022-23

The first presentation was on Fiscal Year 2022-23 for the Measure B Parcel Tax.

Presentation on Measure B FY 2023-24

The second presentation was on Fiscal Year 2023-24 for the Measure B Parcel Tax.

The meeting primarily focused on the financial reports for the last fiscal year, with a discussion on the distribution of expenditures among faculty salaries, student support services, and other costs.

There was also an emphasis on the importance of understanding how the budget benefits students and the process of checking and balancing budget allocations.

The discussion focused on the financial reports for the last fiscal year. The majority of expenditures went to faculty salaries (64%), followed by student support services (24%) and other expenses. It was revealed that a significant portion of the budget is allocated to classified salaries. The conversation also touched upon the differences in allocation between colleges and the suggested allocation for expenses.

There were inquiries as to how the budget allocation level differences between the colleges. The committee discussed the process and checking and balances of budget allocations. The importance of understanding how the budget is benefiting students was emphasized.

It was agreed with management and the committee that the College Vice Presidents of Instruction and Vice Presidents of Student Services will provide an update (in Spring) at the next meeting at the end of April 2024.



6. Meeting Schedule

Generally, the Parcel Tax meets once or twice per semester. We will need to meet at the end of or later in the Spring to complete the template report.

There is a templated report that the Parcel Tax Committee submits at the end of Spring or in Summer to the Board of Trustees before October. It documents the committee's functions and if the Peralta District met the Parcel Tax requirements.

The date for the next meeting was decided to be Wednesday, April 24, 2024, in the Board Room and the next meetings are September, 2024 and February, 2025.

Note: The District will invite the Vice Presidents of Instruction and Vice Presidents of Student Services to the next meeting scheduled for the end of April 2024.

7. Other Announcements

There was a concern providing Ms. Mali Watkins with a copy of the agenda and documents. The Finance Department was not sure if the information was received, and we will continue to reach out to the committee member.
