This bill requires the California Community Colleges, on or before July 1, 2024, to adopt a common course numbering system for all general education requirement courses and transfer pathway courses, and require each community college campus, on or before July 1, 2024, to incorporate common course numbers from the adopted system into its course catalog. During the ASCCC 2022 Curriculum Institute, attendees and participants had many recommendations, cautions, and questions about the massive undertaking of the California Community College common course numbering system.

On April 25, 2022, the Intersegmental Committee of Academic Senates (ICAS) received and voted to approve a recommendation from the ICAS Special Committee on AB 928 (Berman, 2021) that revises the current Intersegmental General Education Transfer Curriculum (IGETC) framework. The proposed framework is clear and transparent, and it will provide a singular transfer pathway that holds the total number of course units to 34 as required by the law while maintaining many key curricular elements important to faculty and moreover beneficial to students of all three systems. ICAS is currently consulting with student leadership from all three segments on the name of the new GE transfer pathway, which will be shared when their work is completed.

Memorandum ESS 22-300-009: Associate Degree for Transfer: Guidance on Degree Versioning Phase-Out
The purpose of this memorandum is to notify all colleges of policy changes regarding the phaseout of Associate Degree for Transfer (ADT) degree versions when the Transfer Model Curriculum (TMC) undergoes substantive changes. To date, only the Business Administration TMC has undergone a substantive change since the TMC was established in 2010. The guidance contained in this memorandum pertains to that TMC currently in transition and all TM Cs that undergo changes in the future.
